Drone Photography Session

There is a \$150 per half hour fee for drone photography/ videography sessions at our farm with a minimum of 1 hour per session. Sessions are always booked outside of our normal business hours and must be scheduled and paid at least 2 weeks in advance. Drone operators must have a proper drone license, availability is limited, drop-ins are NOT permitted, and booking is at the full discretion of Lavender Hill Farm. To reserve a drone photography session, send an email including date and time requests to events@lavenderhillfarm.com.

Photoshoot location requests and an alternate weather date must be scheduled at the time of booking. Date approval, submission of payment, proof of drone license and this completed form will reserve your session. We accept all major credit cards. Drones must remain in their carrying cases until the scheduled time slot and a LHF employee is present AND has given the go ahead.

Our 2024 summer season farm hours are 10am – 5pm, May 10 – October 27. Trespassing is unlawful and not permitted. Our farm is open to the public, event goers, employees, and fellow lavender lovers. Paying any fee does NOT give exclusive rights or access. Please be considerate and kind to others and respect our farm. NO PETS. NO REFUNDS. Lavender Hill Farm reserves the right to refuse photographer access at any time for any reason.

The photographer(s)/videographer(s) and photographed party(s) hereby agree to the following:

- 1. I grant Lavender Hill Farm, those acting with permission, or its employees, the permission to use photographs or videos I have taken or those of me and my family with or without my name for various purposes, including, but not limited to public relations, social media, advertising, web content, illustration and publicity.
