### *After-Hours Private Photography Session*

There is a \$100 per hour fee for private photography sessions at our farm with a minimum of 2 hours per session. Sessions must be scheduled and paid at least 2 weeks in advance. Additional golf carts can be requested at \$25 per hour. Private sessions are booked outside of our normal business hours, availability is limited, and booking is at the full discretion of Lavender Hill Farm. Photoshoot location requests and an alternate weather date must be scheduled at the time of booking. Date approval and submission of payment and this completed form will reserve your session. We accept all major credit cards.

Our 2026 summer season farm hours are 10am – 5pm, May 6 – November 1. Trespassing is unlawful and not permitted. Our farm is open to the public, event goers, employees, and fellow lavender lovers. Paying any fee does NOT give exclusive rights or access. Please be considerate and kind to others and respect our farm. NO PETS. NO DRONES. NO REFUNDS. Lavender Hill Farm reserves the right to refuse photographer access at any time for any reason.
